12. Best Evaluated Bids:

The Bid Evaluation Committee after deliberations, apportioned and recommended as follow:

- 1. The bid is split amongst the bidders who are Manufacturer or Value Adder. The following Companies namely Chakula Investment Group, Talamo Foods and Caterserve Namibia were recommended based on local manufacturer and local value addition preferences as per the bid requirement.
- 2. Chakula Investment Group and Talamo Foods were recommended for five (5) regions with highest quantities each and Caterserve Namibia was recommended for the remaining four (4) regions with lower quantities because there were also recommended for the supply of cooking oil for all 14 regions.
